LinerPro round bottom liners are available in 12, 16, 30, 55 and 85 gallon sizes.

Material Choices

All liners are made in America from FDA-approved films.

Low-density polyethylene is intended for general use and provides superb tensile strength and elongation, as well as high resistance to tears and flex cracking. Low-density polyethylene is designed for applications up to 175°F.

Polypropylene is designed for hot-fill applications up to 270°F.

Anti-stat contains an internal anti-stat agent to aid in the reduction of static build-up, thus reducing dry chemical static cling and chance of ignition of flammable materials.

High-barrier foil provides a high oxygen and water vapor barrier and is constructed of sides made from a lamination of polypropylene-aluminum foil-polyethylene and a bottom made from a polyethylene-foil-polyester lamination.

Chemliners are manufactured from a multi-layer co-extruded film that uses nylon as the barrier core to withstand many chemicals, paints and solvents that normally break down standard liners or inserts.
